Hi All,



There's been some discussion locally around the minimum length of games for it to be counted as WFTDA / REG vs WFTDA / OTHER

I recall at some point a few years ago there was a communication that said 40 min games (as long as there was **no** other rule deviation) still counted as Regulation - but can't seem to find it. There's been some discussion recently around these games not counting as Regulation, and they should be listed as WFTA / OTHER.

One version of the OHD Manual (linked *from* the manual https://docs.google.com/document/d/
IM7efc8znw5ZK7272\_aWIXBU18Zci9bBYQfDgMXof-I0/
edit#heading=h.5f2p2hgfbivj) indicates that regulation must *Follow the ruleset* (see below)

#### 3.2 Identify your Game Type

Game Type is the category into which a game falls. Your Officiating History Document is designed to differentiate several kinds of game type, which are valuable for people seeking to staff or evaluate you for games of that type.

A game can fall under multiple associations and game types. You should choose the combination that best suits your officiating career goals. Below are how to determine game type based on association.

this classification is correct, no further action is needed. For example: short games of under 40 minutes duration do not fall under the WFTDA/MRDA/JRDA rules and so must be classified with the Association listed as Other. Such short games must be changed in your history document as far back as 15th May 2015 to be listed with an Association of "Other", to support Certification requirements.

If the game doesn't match any of these, then list the Association as Other. Other games will be highlighted in yellow and will not be counted in the summary tab.

 For example: short games of under 40 minutes duration do not fall under the WFTDA/MRDA/JRDA rules and so must be classified with the Association listed as Other. Such short games must be changed in your history document as far back as 15th May 2015 to be listed with an Association of "Other", to support Certification requirements.

Action Required: Games that fall properly classified in the National category are to be retroactively changed back to 1st July 2017. No other games need further modification.

You're not crazy - Or else we both are. I am CERTAIN there was guidance, in writing, somewhere that said that a game played entirely according to the rules with no change other than 20 minute periods could be listed as regulation. I believe it was on the "instructions" page of one of the older game histories, but it may have been edited out by the document owner at some point.

As long as we're at it, could we get clear, unambiguous directions on how to assign the "Association" field on the new history? Prior versions of the game history had detailed instructions, but there's basically nothing to help answer that question now. It would be nice if all the officials for a game could, without needing to ask for help, determine what to list in that box, and ideally come to the SAME conclusion for a given game.

The second document you cite says that all boxes with an "X" must be met for it to count. So for Regulation it must be played "more or less according to the Rules..." and it must follow the Rules, Officiating Procedures, and RMG. So the real distinction they're drawing is do you follow the Rules, or the Rules plus those other documents?

There's certainly a valid question as to what percentage of a game needs to be played for it to

count, say, in the event it were to be cut short due to electrical or natural causes (like a hurricane). But I don't know that we've ever answered that, despite it literally happening a handful of times. And then, would we put that in the Rules, and make it the case for all three associations that E.G. 40:01 played of a game that is forced to end due to outside circumstances counts for all intents and purposes?

The definition of Regulation is given in the Sanctioning policy:

A **regulation game** is a game played according to *The Rules of Flat Track Roller Derby, the WFTDA* 

Officiating Cues, Codes, and Signals, and the WFTDA Officiating Procedures for The Rules of Flat Track Roller Derby with no deviations. All leagues holding WFTDA Insurance or insurance policies with reciprocity with WFTDA Insurance must adhere to the WFTDA Risk Management Guidelines. These guidelines are recommended for all other play.

Note the term "with no deviations." This includes the length of the game. This definition has been in place since 2016, when Whacks Poetic (then the Rules Chair) moved all sorts of different policies out of the ruleset and into other documents. Prior to that, the definition of "Regulation" was even more restrictive as it required the teams playing to be from different WFTDA leagues.

But, what you and Smasher are probably thinking of, is whether a game counts as an "other" game. "Other" games have historically been understood to need to have periods at least 20 minutes long, or you haven't really played "a game" of Flat Track Roller Derby, for any governing body. So there's the "other" game type (which is more-or-less the rules) and the "other" association (which is, WHOSE rules and policies). This could be clearer, but both the OHD and Cert page have it correct and are not in conflict.

For example, in the Cert website, all six rows have the requirement of "must be played more or less according to the rules." This clearly indicates that having an X in a column is a requirement for the row.

So, "Regulation" has the requirement of "follows the rules and procedures and guidelines," as do champs, playoffs, etc. If a game does not follow the rules, procedures, and guidelines, it can not be marked as "Regulation." And if it is under 40 minutes long, it cannot even be marked as being a WFTDA, MRDA, or JRDA game.

Hope this helps -- if you have suggestions on how to make one or both documents clearer I am happy to update the cert site!

Note: I'm making this post as Chair of Certification.
However, Certification does not "own" the Officiating
History Document. Certification is only one "customer"
of the Officiating History Document. Some people
want to list everything they have ever done, and the
OHD wants to help them do so. But that does not
mean that the thing they did provides meaningful
context to Certification, whose goal is to recognize
proven performance in wftda's specific flavor of roller
derby games. There's a lot of grey area and we
encourage anybody who thinks they have a bulk of
work that should count for something, but which
doesn't fit into the definitions provided in our website
or documents, to email us at

I would definitely believe that someone somewhere had written down a falsehood about regulation games, especially in the days before its formalization in the Sanctioning Policy.

However I do not believe that it was written down in "canon," meaning any authoritative source from Certification.

Right now I do not think that there is an unambiguous rubric to be written because people can write down the same game in multiple valid ways. Any regulation game could

be written down as WFTDA, or MRDA, for example. You could write down a Playoff as "Sanctioned" or "Regulation" or "Other." I don't know why you would, but it would not be a lie. I would absolutely agree (as a person, and also as Certification Chair) that formalizing that one MUST write down WFTDA as the association if it is valid to do so, and formalizing that one MUST write down the highest-ranking game type. I think that that would resolve the ambiguity right? (However, as noted, the OHD is not a Certification document.)

Muffin is correct about that timing. I made the



updated policy documents at that time and have tried to track changes at the bottom of each from that point forward so we could keep track of when things were altered. That "without deviations" part of the definition never changed.

I do want to consider the idea of altering the rules to allow for different competitions to hold regulation games (as defined in the Sanctioning Policy) and be able to adjust the length of the game. We are in a time when more flexibility is helpful to our leagues and competitions and many very high-level games (World Cup) have shorter games for the initial seeding rounds.

For example, FIFA's rules of the game: "A match lasts for two equal halves of 45 minutes, which may only be reduced if agreed between the referee and the two teams before the start of the match and if in accordance with competition rules."

But I don't know what you all would think about that from an officiating and certification perspective, but from a facilitating as much derby as possible and providing opportunities for as many participants as possible perspective, it's in line with our organization's goals.

Danger Muffin I'd like to be careful about the word "rules" -- to be sure we know when we are talking about "a policy for saying whether a game is Regulation" ("policy") vs the Rules of Flat Track Roller Derby (RFTRD). The RFTRD do not, can not, should not, and never have, defined what it means to be a "regulation" game...it's Regulation Policy that requires that you follow the RFTRD.

So -- if we are talking about changing the RFTRD to say that a game can be two 20-minute periods, and if Sanctioning will follow (so you could sanction those games), then we don't need to change the Regulation Policy, we just introduce more flexibility into our sport overall. Certification would be ok with this. I think this is what Riot was saying. But that was not the initial question in the thread.

If, instead, we are talking about changing the Regulation Policy to drop the requirement that the game follow the RFTRD by adding exceptions, or anything that would meaningfully draw new lines between Regulation or Sanctioned games, that would be harmful in my opinion. That's what the original post was about, and since Bones mentioned qualifying for World Cup rather than citing

WFTDA Regional Championships or Global Championships, I wanted to make this distinction clear.

Danger Muffin SANC means that a governing body has confirmed that the game meets the sanctioning requirements. So if that is true it's a sanctioned game. So if you are saying, that an international governing body has sanctioned the game despite the track being wrong, I you would still call it SANC. If it was the WFTDA you'd do WFTDA/SANC regardless of other qualities. (But I really hope you did not sanction a game on a nonstandard track.)

However, I'm getting the feeling that that is not your question, and you're asking if a game can be considered Regulation if the track is wrong. It cannot. If anything is wrong it is not Regulation. That one is easy. When you say "except" you know it's not Regulation.:)

So it is clearly not SANC or REG. But is it even a WFTDA / OTHER game? This is discretion. If you aren't playing the game to the standards, what

ARE you playing? Is it really basically still a normal game like, maybe you shaved some time off the period clock? Then yes. Is it pretty far, as far as "less than 20 minutes per period"? Then no. Similar discretion would be applied to other rules that you bend. So you have to make the call about that one based on your experience on the track. We did not see the track so we can't help guess.

But when you were there was it just a totally normal game and you couldn't notice that the track was short? Then totally mark WFTDA/OTHER. Or, was there a lot of extra skaters sliding out to the outside, and OPRs falling down b/c they try to corner too hard, because they trained to a different track, so the gameplay is different? Then probably not a WFTDA game.
