WFTDA Membership By The Numbers

- Total Member Leagues: 437
- Total Inactive Members: 57
 - 2 planning to return with renewal
 - o 33 inactive members in the US, 5 Canada, 19 outside US/Canada
 - o 10 inactive members from the US have active WFTDA insurance
- 10 New Member Leagues joined from 2020-2023

WFTDA Competition By The Numbers

- Total Teams Competing: 428 (380 active leagues)
 - 54 additional teams
 - 7 leagues have 3 teams competing
 - 40 leagues have 2 teams competing
 - o 8 leagues are active (paid dues) but have no teams competing
- June 1, 2023 268 leagues with charters submitted 63%



WFTDA Competition By The Numbers

- 2023 sanctioning numbers to date:
 - o Q1: 30 games
 - o Q2: 163 games
 - o Q3: 10 games so far
 - o 35 tournaments to date

WFTDA Competition Basics

Season and Pathways

- Season runs from January 1, 2023 until approximately April 1, 2024
- Next cycle starts July 1, 2024 (and includes Global Champs)
- o Regional gameplay pathway to Hydra via Regional and Global Champs
- Geographically Unrestricted Region (GUR) for intraregional play and a global ranking but no Hydra pathway

Rankings and Eligibility

- One game required to get a ranking
- Teams must play five "close" games to be eligible for Regional Championships
- Rankings algorithm is capped to allow for more game play

Charter Rules Changed

- Skaters may be on more than one charter (in any league)
- Teams may have no more than 8 shared skaters regular season/3 in postseason

Competition Updates

- The **new rankings calculator and game site** is under development and will be tested soon. We will release it in the coming months.
- WFTDA has entered into a partnership with FFRS, RDD, and Five Nations to have their competitions dual-sanctioned automatically. Leagues will sanction with their NGB and the NGB will report results and paperwork to WFTDA for WFTDA rankings.
- The initial **hosting bid deadline for Regionals and Champs** has passed. We are reviewing submitted bids and still need some for North America-South and Latin America.



How Do You Submit Charters and Sanction?

- Charters are submitted via a Google Form system linked to the WFTDA Member Portal
 - Leagues must assign role of "Skater" to all skaters for charter
 - Leagues must assign role of "Roster Manager" to individuals submitting charters
 - Due 30 days prior to the game FIRM! first-ever charter, name and number changes, or removing skaters will be effective immediately
- Game sanctioning is submitted via the Game Sanctioning Form and tournaments (at least 3 games between 3 teams) via the Tournament Sanctioning Form
 - All participating leagues "sign" the form
 - Due 30 days prior to the game or you may be assessed a late fee.



Sanctioning Reminders

- Read and follow the instructions on how to submit charters and sanctioning carefully.
 - **For all games in the United States**, make sure your league insurance is up-to-date before you sanction games to avoid delays.
 - If you update your charter (add skaters), use the online form and select amendment. **Remember the 30-day waiting period!**
 - Roster managers must submit the charter form using a Google-compliant email and that email must be used as your login/email in the member portal.
 - The portal, charter roster, uniform and IGRF must all match!
 - Shortened versions of names on uniforms are OK, but if you use a completely different name on your uniform, you must put that name on the charter roster and in the portal.
 - If a skater uses a different name/number on one league and plays for another roster, please let Sanctioning know.

Membership Update



Membership Benefits

- Compete in competitive structures and rankings
 - One team included in base membership cost
 - Teams may enter as many teams as they wish!
- Access to Online Community (https://community.wftda.org)
 - Portal League Admins may assign their own Representatives and give them access (Skater Rep, Officials Rep, Risk Coordinator, Vote Reminders contacts)
 - o Everyone else can join WeFTDA Collective membership
- Voting on ballot issues (Reps only)
- Access to WFTDA Online Education (https://learning.wftda.org)
 - Member Learning (needs to be updated)
 - Officiating training (Basic Cert courses are free and open to all)
 - o Games and Safety courses
 - WFTDI basic first aid course
- Use of WFTDA logo/member patch (when available)
- Discounted WFTDA Insurance (where available)



Membership Program Changes

Competitive Structure Changes

- Dues are now set up with a base price (one charter team) and additional fees for adding more than one team
- No requirement to sanction games or have a team for membership purposes, just pay dues and play WFTDA derby

Voluntary Inactive Status

- o Now limited to 12 months maximum.
- Dues will be prorated quarterly for leagues who return mid-season.
- Current inactive members will be contacted to determine their plan.
- Leagues who need to leave may work out a way to return if they wish.
- Inactive teams cannot vote and cannot participate in competitive play.



2023 Renewal Information

- Dues remain the same this year
 - \$400 US for the member year August 1, 2023 July 31, 2024
 - o Global index leagues (Latam, S. Africa, E. Europe) no dues but must confirm
 - o Additional teams are \$100 US each (3 or more \$300), \$10 for Global Index
 - o Board and Officer leagues pay no dues but must pay full additional team fees

Renewal Timing

- Opens on or around July 1
- Payment is due 60 days after invoicing (around September 1)
- Invoicing and payment on the member portal
 - US leagues pay by credit card or e-check on member portal
 - Outside of the US may pay by credit card on member portal or using Paypal to paypal@wftda.com.



Membership and Insurance are Different!

- Membership dues provide the benefits of membership listed earlier and is renewed annually in July.
- Insurance is additional and purchased separately. Renewal is 365 days from the date it was purchased.

REMINDERS

- Assign an Insurance Contact in the member portal. This individual and League Admins receive renewal reminders 30 days before expiration and on the day of expiration.
- If you are playing in the United States, or carry insurance other than WFTDA insurance, please have your insurance verified in advance of sanctioning (60 days is recommended). Send to insurance@wftdi.com.
- Sanctioning will verify insurance (liability and personal skater medical) prior to game sanctioning and will not approve games/tournaments until insurance is cleared.

What's Next for Membership?

- Review bylaws to ensure they fit the organization currently
- Review and update membership policy
 - What would true membership mean for individuals (Officials, Announcers, etc.)?
- Review and update member requirements
- Update new member learning and recreate guide
- Figure out a plan for member and certification patches
- Get education committees reinvigorated and catch up on education emails, content, etc.



What's Next for Competition?

- Finish updating policies to align them with the new system
- Finish and launch the rankings and games site
- Onboard and organize the permanent competition committees
- Select hosts for 2024 tournaments and begin tournament planning
- At some point in the coming months, Competitive Play will release an analysis of our rankings algorithm and rankings based on games played the first half of 2023.
